The DuPage Community Foundation has a new name and a new look and will now be doing business as the **DuPage Foundation**. The change in name and visual identity was made to update the look of the Foundation and to simplify its name.

"DuPage Foundation is exactly who we are," said David McGowan, Foundation president. "As the leader in philanthropy in DuPage County, our new visual identity will help us put our best foot forward in all respects."

The development of the new visual identity was a project undertaken by the Foundation's Marketing Committee during the past several months. The project was part of a comprehensive plan started in 2013 that focused on helping us increase our visibility within the community, refresh our image, and resonate more strongly with our friends and partners. The new identity and name change were approved by the Foundation's Board at its November meeting and unveiled at the Annual Benefit on November 15, 2014.

# Jim Durham Memorial Fund Established

The DuPage Foundation is pleased to announce the establishment of the Jim Durham Memorial Scholarship Fund for Communication Arts. The fund was created by the Durham family in memory of Jim, who was best known as the "voice" of the Chicago Bulls and the NBA on ESPN Radio.

The Jim Durham Memorial Scholarship Fund for Communication Arts has been created to benefit juniors and seniors attending Benedictine University in Lisle, who are pursuing a bachelor's degree in communications, with preference given to those seeking a career in sports broadcasting. Recipients of the scholarship must be individuals who have demonstrated great personal integrity in their own lives and who are driven by a passion for excellence. The scholarship will be advertised by the University to its sophomores and juniors in the spring of their respective semesters with awards issued the following fall to be used during the recipients' said Jim's wife, Helen Durham.

"Jim was, by nature, an encourager of others. A young friend recently wrote, 'Jim helped people around him do what God was calling them to do. That was truly one of Jim's greatest legacies. And it would be wonderful to honor Jim's faith by giving assistance to people who want to make a difference in the world. I only met Jim a few times, but he made me feel special. He made me feel like I could accomplish anything, and he made me feel like my work was important,'" related Helen.

"Jim was at an A-level from the get-go," wrote Brian McIntyre, former senior communications advisor to the NBA commissioner. "And he wasn't just one of the best announcers of all time; he was in the human being Hall of Fame. He treated people like gold and just lived his life the right way."

Jim passed away from natural causes on November 4, 2012, at the age of 65. He began his profes-

He worked at WJBC in Bloomington, Illinois, prior to his 18-year career as the voice of the Chicago Bulls, with his broadcast partner Johnny "Red" Kerr. For 18 seasons, he was the

lead play-by-play announcer for The NBA on ESPN Radio with his broadcast partner, Dr. Jack Ramsay. Jim also worked for the Chicago White Sox, the Dallas Mavericks, Turner Sports, ABC, CBS, NBC, and the Houston Astros.

# DuPage Medical Group Celebrates Five Year Anniver

The DuPage Medical Group (DMG) Charitable Fund is celebrating its fifth anniversary as a fund of the DuPage Foundation.

The DMG Charitable Fund is a donor-advised fund that was created to accomplish the charitable goals of DMG, its physicians and employees who seek to care for the community through charitable giving and volunteer service.

Since its founding in 2010, the DMG Charitable Fund has made grants totaling nearly \$625,000. In addition, several hundred DMG physicians and employees have donated thousands of volunteer hours for the benefit of DuPage County residents. One of the founding physicians is Dr. Ashish Bhatia, chairperson of the DMG Charitable Fund.

"We as physicians take care of people every day," Bhatia said. "By setting up the Charitable Fund, it allows us, our entire organization

and our families to give back in an organized fashion."

As the Charitable Fund's fiscal agent, the DuPage Foundation provides administrative support to the fund so that its representatives can focus on increasing the resources available to make impactful grants throughout the community.

"We set out to coordinate our giving," said Peri Todd, director of the DMG Charitable Fund. "This includes our financial giving, volunteers and in-kind donations."

DMG has more than 50 locations throughout DuPage County, Will County and western Cook County. Its Charitable Fund aims to serve these communities' three greatest needs—food, shelter and healthcare related assistance.

"The Charitable Fund was founded by physicians who felt it was their responsibility to give back to the community," said Todd. "And it allows them to do just that."

"When I first joined DMG, I did a lot of volunteering outside the group," said Bhatia. "People kept asking how they could get involved so we decided to provide that opportunity."

"Not only do the physicians support the Charitable Fund but it allows DuPage Medical Group to serve the community outside of the clinic," said Todd. "Patients have said, 'I'm glad I go to DMG because they give back to the community.' Patients want to be on our team."

"The Charitable Fund is indeed the practical extent of what we as physicians are all about—helping people," said Dr. Kenneth Sanders, an orthopaedist with DMG.

The DMG Charitable Fund benefits the community in numerous ways but as Bhatia points out, it benefits DMG employees as well.

"The Charitable Fund engages every member of DMG and allows

them to do something good together," said Bhatia. "For example, tomorrow we will be volunteering for Habitat for Humanity, and our COO could be working alongside one of our administrative assistants, and they might not have ever met before then."

Bhatia cites another advantage of the Charitable Fund for employees: "It gives our employees an opportunity to go out often with their families and friends, and see first hand what the needs are in our community."

Funding for the DMG Charitable Fund is obtained through donations from physicians and employees, sponsorships, through two major events held each year: The Care Affair (a cocktail social and auction) and a golf outing.

"Although the cornerstone of financial giving comes from physicians and vendors, volunteer opportunities and in-kind donations allow employees to step up to the plate and get involved in the giving process as well," said Todd.

"Each department has a 'charitable champion' who is responsible for educating and rallying the staff to support our charitable initiatives."

"One thing that makes the Charitable Fund a strong organization is having a strong Board," said Bhatia. The Board of the Charitable Fund is comprised of physicians but also includes community stakeholders. "The common thread of everyone at the table is that they all care about their community and about improving the quality of life for everyone in our community,"said Bhatia.

"The DuPage Foundation has done such a great job of evaluating the needs of the community," said Bhatia. "As a Charitable Fund of the DuPage Foundation, we are able to look at the needs of the community—which keep growing—and evaluate how we can help."

One of the agencies the DMG Charitable Fund supports is the People's Resource Center food pantry. Todd explained that initially some people questioned why a food pantry would be supported by a health-care organization.

"Food is a basic health necessity. Some people are making decisions between buying food and filling their prescriptions," Todd said. "By supporting a food pantry, we are directly impacting a person's health."

For the past four years, DMG employees, families and friends have been volunteering every Saturday at the People's Resource Center's Westmont food pantry location. Food drives at more than 30 DMG locations often designate a "food of the month" that focuses on healthy living.

"In establishing the Charitable Fund, we wanted everyone to be able to give whether it be time, financial resources or a can of corn," said Todd.

DMG is one of the leading employers in DuPage County with more than 3,000 employees including more than 440 physicians.

"One of the benefits of working with the DMG Charitable Fund is that you learn more about community organizations," said Todd. "Patients and sometimes even our employees can be referred to agencies and benefit from the awareness that comes from this interaction. It's really a winning combination."

# **Investments in Local Collaboratives Paying Off**

## Financial Fitness Program in Good Hands

For the past six years, the DuPage Foundation has been a leader in the community on the issue of financial literacy. During that time, the Foundation has facilitated Money Smart Week DuPage, a local public awareness campaign to help consumers better manage their personal finances, and has engaged many partners to participate, including businesses, financial institutions, colleges, universities, libraries, and not-for-profits.

"Now that Money Smart Week DuPage has become a staple in the County, we have stepped down and turned over the reins to a local business owner to carry on the leadership of this program," said Barb Szczepaniak, Foundation director of programs. "The Foundation is directing its attention in other ways to expand financial literacy programming in DuPage."

At a convening facilitated by the Foundation in November 2012, local not-for-profits indicated they were struggling to find a comprehensive financial literacy program that addressed the unique needs of their low-income clients. In response, the DuPage Homeownership Center (DHOC) developed the Financial Fitness Program through which group workshops and one-on-one financial counseling are offered for clients from multiple local not-for-profits. The Foundation provided \$45,000 in grant funding from the general endowment as well as the Sue Wallace and Wheaton Bank & Trust donor-advised funds to help DHOC get the program off the ground.

"We are truly grateful for the support the Foundation has provided for our Financial Fitness Program," said Debra Olson, executive director of DHOC. "Through the assistance of the Foundation, the need was identified, program elements determined, partnerships created, funding obtained, and client services achieved."
