DuPage Community Transformation Partnership Fund Grants More Than \$1 Million to Support Social Service Not-for-Profit Organizations

n July, the *DuPage Community Transformation Partnership* (DCTP) *Fund* awarded more than \$1 million in Immediate Intervention grants to 16 social service not-for-profit organizations serving DuPage County residents in the areas of food insecurity, housing instability, mental health and substance use disorder.

The *DCTP Fund* was established earlier this year after DuPage County and DuPage Foundation solidified a strategic grantmaking partnership to support social service not-for-profit organizations helping DuPage County residents most severely impacted by the COVID-19 pandemic. In January, the DuPage County Board executed an agreement to allocate federal funds received through the American Rescue Plan Act (ARPA) to DuPage Foundation for the grant program. Through 2026, the *DCTP Fund* will award \$10 million in grants to address immediate and longterm needs in the community in response to the COVID-19 health emergency.

The purpose of DCTP Immediate Intervention grants is to provide financial resources to enable organizations to respond to the immediate needs of their clients and/or to quickly increase capacity of the organization to deliver efficient services.

"These grants provide the opportunity for transformative change for our community," said DuPage Foundation President & CEO **Dave McGowan**. "Through these grants and our partnership with the County, we are routing much-needed assistance to many of our notfor-profit partners that have been searching for solutions to meet the sweeping demand for their services. The needs in our community have grown significantly since the onset of the pandemic, and we are proud to deploy help where it's needed most."

Northeast DuPage Family & Youth Services (NEDFYS) received a DCTP Immediate Intervention grant to expand mental health counseling for middle school and high school youth. NEDFYS Executive Director Shannon Hartnett visited the DuPage Foundation Board of Trustees meeting in July and spoke about the struggles NEDFYS was facing to keep up with the demand for mental health counseling.

Through the DCTP grant program, organizations can apply for Immediate Intervention and Transformational grants. To be eligible to apply for a grant, an organization must be a 501(c)(3) social service not-for-profit providing assistance in the areas of food insecurity, housing instability, mental health, or substance use disorder that meets at least one of the following criteria:

- Have more than 50 percent of its total clients be DuPage County residents; or
- Provide services in facilities physically located in DuPage County; or
- Have a DuPage County advisory board. ■

"This cycle of *Community Needs* awarded grants for programs focused on improving behavioral and mental health, food pantry capacity and support for children and people with disabilities," said **Megan Shebik**, DuPage Foundation Trustee and Grant Committee chair. "We also recommended grants for emergency assistance, as the effects of COVID-19 continue to interrupt daily life and operations for many organizations seeking to help our residents."

Additional donations from DuPage Foundation's donors and donor-advisors increased the spring 2022 *Community Needs* grant budget by 26 percent.

"Our not-for-profit partners have seen increased demand for their services for more than two years, and are still facing situations exacerbated by the pandemic," said **Barb Szczepaniak**, DuPage Foundation vice president for programs. "We are grateful to the donors and donor-advisors who make it possible for the Foundation to go the extra mile when it comes to *Community Needs*. Thanks to their generosity, we can award more grants and increase our reach throughout the community." ■

Megan Bradshaw Memorial Scholarship Winner Produces Impactful Documentary on Water Crisis in Kenya



hen he was a senior at Wheaton Warrenville South High School, Mojeri Coker was an average student with big dreams and a bigger personality.

"I would aim to cheer people up while in the hallway at school," said Coker. "I liked to have a positive impact on someone's day."

And others took notice. In the spring of 2016, Coker was chosen by the school faculty to receive an award from the *Megan Bradshaw Memorial Scholarship Fund* of DuPage Foundation towards his tuition for College of DuPage (COD). The scholarship fund was created by the late DuPage Foundation co-founder Jerry Bradshaw and the late Trustee Emerita, Betty, in memory of their daughter, Megan. Jerry and Betty named DuPage Foundation as the beneficiary of a life insurance policy to support the scholarship fund in perpetuity.

"It was an impactful moment in my life," said Coker. "I was touched by the story of the Bradshaw family."

While he started at COD as an engineering major, Coker always had a passion for storytelling. During his time working at a local escape room, he made a short marketing video for the business. Coker's supervisor asked if he would be interested in helping document a water project in Kenya for his father, who had done a lot of philanthropic work.

Soon, Coker was on his way to Kenya and, what was intended to be a five-minute video, turned into a feature-length award-winning documentary. *Pipe Dreams* documents the true story of Silvester Mwami, a Kenyan villager who embarked on a 20-year journey to save his village from a 50-year drought.

During his time at COD, Coker landed an internship at ARCO/Murray in Downers Grove and shared his experience making Pipe Dreams. Leadership was impressed with his work and offered him a full-time job as their lead video producer. Since then, ARCO has sponsored clean water projects through MicroFinancing Partners in Africa (MPA), a notfor-profit organization dedicated to the cause. In partnership with MPA, Coker has leveraged the film as a platform to help raise funds for its Clean Water Program and awareness of the water and sanitation crisis. To date, *Pipe Dreams* and MPA have raised over \$200,000 providing water access for thousands. The film has been screened across the country and won Best Documentary from the California Independent Film Festival in 2019.

As far as the impact of the scholarship on Coker's unexpected career, he is thankful.

"There really aren't many instances where people have been rewarded for having good character," he said. "But that's what the scholarship did for me."

She is also chair of the **DuPage Community Transformation Partnership**, a five-year, \$10 million grant program. Megan is a Trustee, chairs the Bylaws Committee and has served on its Executive and Strategic Planning committees.

The Shebiks always included their three children in philanthropic activities – from volunteerism to donating – teaching them the importance of service and community. They recently opened a second donor-advised fund at the Foundation for their children to recommend grants benefitting the causes they care about most.

Together, the Shebiks have created the foundation of a lasting legacy which has already made significant impact in DuPage County and beyond. Congratulations, Megan and Steve, and thank you for your unwavering dedication to our community!

- Cash gifts must be received (or post-marked, if mailing checks) by Saturday, December 31.
