they highlighted the substantial strides made this past spring and summer to bring Arts DuPage to fruition. Arts DuPage is a new county-wide arts council focused on promoting creativity and nurturing engagement and investment in the arts throughout DuPage County. From building community support for the initiative, to forming a new committee, to creating a new logo, and developing a new online resource, Arts DuPage has made colorful progress.

Members of the **Arts DuPage Committee** were formally approved during the Foundation's Board of Trustees meeting on

July 21. Slated to meet twice annually, the Committee will provide general direction, expertise and advocacy for the implementation

This past August, the Foundation unveiled its new Arts DuPage logo. "The logo is a significant step toward establishing a visual identity and brand for not only the initiative, but for arts and culture throughout DuPage County," said Tylke. "With one image we are able to speak for and represent our community's arts and culture sector." The logo came to fruition by tapping into the branding expertise of the Foundation's **Marketing Committee** and **Trittenhaus Design**. The Committee was tasked with developing a logo with the flexibility to stand on its own and also live within the

Foundation Celebrates 30 Years of Raising the Quality of Life throughout DuPage County

September is a time of reflection for everyone at the Foundation, and 2016 marks a significant milestone. The DuPage Foundation is extremely proud of its beginnings 30 years ago. In 1986, Brooks McCormick, Mary Eleanor Wall and Jerry Bradshaw established the Foundation. They were joined by Elizabeth Eben, Jody Ellyne, J.R. Horton, Carlton Nadelhoffer, Hartman Stime and Charlie Thurston on the Foundation's very first Advisory Committee.

At that time, McCormick sat on the Executive Committee of **The Chicago Community Trust (CCT)** and saw the value of creating a charitable entity wholly-focused on the booming area west of Chicago in DuPage County. Beginning as an affiliate fund at CCT, the Foundation grew rapidly and fully separated from CCT in July 1994 to become its own entity.

Since its inception, the DuPage Foundation has built an endowment to **approximately \$65 million** among more than **300 unique funds**. During 2016, the Foundation achieved two significant giving milestones. Just recently, it officially awarded **more than \$27 million** in cumulative grants. To place this milestone in perspective, the Foundation celebrated the \$1 million mark in 1998. It took 26 years to award the first \$13.5 million and only four years to award the next \$13.5 million. In late August, the Foundation awarded its **5,000**th grant. The grant, to **Northwestern Memorial Foundation** for **Central DuPage Hospital (CDH)**, was recommended by the **Dale Family Fund**,

Bright & Early DuPage: Making A Good Education a Local Sensation


Community by community, **Bright & Early DuPage** is engaging and uniting local businesses, organizations, and individuals to build awareness for and facilitate access to early childhood education and support services for DuPage children and their families. Having committed hundreds of thousands of dollars in support for the initiative over the next several years, the Foundation has already helped launch and implement several collaboratives in **Addison**, **Bensenville**, **Birth to 5 Community Coalition**, and **Wheaton/Warrenville**, as well as a **regional hub** in DuPage County.

Since the **Addison Early Childhood Collaborative (AECC)** was launched in 2014, **Addison School District 4** has seen significant improvements in kindergarten readiness scores. Using the **Aimsweb** screening tool, the District collects Letter Naming and Letter Sound Fluency scores for all kindergarten students.

Between the 2013/2014 and 2015/2016 school years, the percentage of children considered "on target" (where children should be scoring or performing at that time according to national averages) increased from:

- 44% to 55% for Letter Naming English
- 16% to 39% for Letter Naming Spanish
- 45% to 70% for Letter Sound Fluency English
- 27% to 63% for Letter Sound Fluency Spanish

Assistant Superintendent for Administrative Services **Chuck Wartman** credits these improvements to more students attending preschool, teachers providing lessons based on what students need (based on testing results) rather than following a scripted format, and families becoming better connected to support services outside of school. The AECC, funded by the Foundation, has coordinated myriad outreach efforts to engage and connect the most at-risk families to community services. Additionally, through **Preschool for All** and **Preschool Expansion** funding, 56 new high-quality, all-day early learning slots were created for at-risk Addison students. Foundation support has been cited as the catalyst for the collaboration efforts, which was a key component in applying for funds that significantly contributed to these new slots becoming available.



NGI Supports Northern Illinois Food Bank with Giving and Volunteer Opportunities

The Foundation's Next Generation Initiative (NGI) was thrilled to host more than 50 guests on June 8 for its Sizzlin' Summer Mixer at Reserve 22 at the Village Links in Glen Ellyn. Generously sponsored by a corporate donor who wishes to remain anonymous, the event provided a wonderful evening of delicious food, fun and comradery.

In addition, the NGI was delighted to showcase and support the work of one of our area's most impactful not-for-profit organizations: **Northern Illinois Food Bank (NIFB)**. **Hester Bury**, NIFB's director of corporate and foundation giving, gave a brief presentation that highlighted the organization's mission to lead the northern Illinois community in solving hunger by providing nutritious meals to those in need through innovative programs and partnerships.

During the mixer, \$1,670 was raised from attendees to fund a mobile food pantry. The NGI then provided an additional \$1,200 in matching dollars from its Next Generation Fund to support a second mobile food pantry.

The first mobile pantry was held on Tuesday, July 26, at the Henry Hyde Resource Center in Addison. The second mobile pantry was held on Thursday, August 25, at the Marian Park Apartments in Wheaton. For both dates, the NGI team unloaded the trucks filled with staple food items such as cereal, juice, ground turkey, chicken, rice, potatoes, packaged dinners, canned fruit, milk, and more. The dedicated volunteers distributed the food items to the mobile pantry's clients, helped the clients carry boxes of food to their cars, and broke down the sites at the end of each day. In total, the NGI provided groceries for more than 219 families benefiting both adults and children. "It was a wonderful reminder of why we do what we do," said Derek Johnson, NGI Chair. "We are truly inspiring philanthropy for the next generation."

Ensuring a Legacy Through Simplified Giving

Inspiration often strikes in unexpected and unprecedented ways. When **Paula Partipilo**, a DuPage County resident, discovered a hand-written note belonging to her uncle, she was moved. It read:

"When you are surrounded by that state of grace where nothing else matters except the feeling you have within yourself, that is your intersection with destiny."

Partipilo's uncle, **Daniel Ruscitti**, had strong charitable ambitions and a heart for giving back to those most in need. The causes for which he felt the greatest passions related to helping adults afflicted with HIV/AIDS, and supporting the educational needs of children living in the inner-city.


When her uncle passed away in April 2000, Partipilo experienced her personal intersection with destiny and established the **Daniel R. Ruscitti Charitable Foundation**, a private foundation, to channel and preserve her uncle's philanthropic work. She was committed to honoring her uncle's legacy and allowing his philanthropic spirit to thrive by supporting the causes to which he felt most connected during his lifetime. Through the private foundation, Partipilo provided financial support to several organizations that aligned with her uncle's charitable goals.

While a private foundation can support many diverse causes, there are often burdensome administrative challenges that accompany that method of grantmaking. For many individuals, creating and maintaining a private foundation can be a cumbersome and costly undertaking. In 2011, Partipilo decided she needed assistance and was referred to the DuPage Foundation by **Trust Company of Illinois**. She collaborated with **Barb Szczepaniak**, the Foundation's vice president for programs, to help navigate the complexities associated with grant administration. Partipilo was impressed by how smoothly the DuPage Foundation handled the logistics and due diligence related to her needs.

Following her positive experience, Partipilo explored the cost savings and other advantages of converting her private foundation into a donor-advised fund at the DuPage Foundation. Because the DuPage Foundation is a publicly-supported 501(c)(3) organization, there are less restrictions in comparison to private foundations. She completed the transfer in 2016 allowing her to preserve the identity of her uncle's foundation while freeing her to focus 100% on its mission and grant priorities.

"I look forward to continuing my uncle's legacy of philanthropic good-doing," said Partipilo. "The DuPage Foundation provides the greatest opportunity to maintain his charitable wishes at an affordable cost while relieving the administrative burden for me."

Recently, Partipilo and Szczepaniak have worked together

The IRA Charitable Rollover is Now Permanent!

Last December, Congress and the President made the IRA Charitable Rollover permanent. This special provision allows individuals 70½ and older, who do not need all or a portion of their IRA income, to make annual tax-free charitable gifts of up to \$100,000 each from their IRAs to the DuPage Foundation and their other favorite charities without recognizing the assets transferred as income.

Why Make an IRA Rollover Gift?

- It qualifies toward your required minimum distribution (RMD) which can help you reduce your income and pay less taxes.
- You can benefit your favorite causes and charities without using cash or other assets.
- If you want to give over and above your normal annual giving this year, an IRA Rollover gift does not count toward the 50% annual limitation on charitable gifts.

- In addition, an IRA Rollover Gift may prevent you from:
