

n August 13, Foundation representatives and the DuPage County Board welcomed grant recipients who were awarded \$1.03 million in Immediate Intervention grants through the *DuPage Community Transformation Partnership* (DCTP). These grants will help fund the work of 16 social service not-for-profit organizations serving DuPage County residents.

"The Immediate Intervention grant program was designed to have the highest level of impact in our communities and provide relief quickly to those in need," said DuPage County Board Chair Deborah Conroy. "Each year, the Immediate Intervention selection process allows us to effectively assess what the most pressing issues are in our County and direct our grant dollars directly to address those service or funding gaps. Collaborating with DuPage Foundation streamlines the process and ensures that we can make an important difference in these critical areas including mental health, substance use, housing instability, and food insecurity."

In 2022, the DuPage County Board executed an agreement to allocate federal funds received through the American Rescue Plan Act (ARPA) to DuPage Foundation for a five-year, \$10 million grant program to address immediate and long-term community needs. A committee of DuPage County and DuPage Foundation staff, Board members, and volunteers review applications and select the DCTP grantees. To date, more than \$6.8 million has been awarded in Immediate Intervention and Transformational grants.

"Many of our refugee, single mother, and low-income family clients come to us in moments of deep vulnerability—fleeing violence, escaping domestic abuse, starting their lives over from scratch, or struggling to keep their children safe. Emergency assistance is more than a roof over their heads; it is a lifeline of safety and hope, allowing them to breathe easier and take the first steps toward rebuilding their lives."

Despite being made up of communities with tremendous resources, the needs in DuPage County remain significant and urgent. DCTP Immediate Intervention grants provide grantees financial resources to respond to immediate needs of clients and allow agencies to quickly increase their organizational capacity to deliver resources within the target service areas.

Mercy Housing Expands Impact Using Community Connections

Mercy Housing Lakefront (MHL) develops affordable, program-enriched housing for families, seniors, and people with special needs who lack the economic resources to access quality, safe housing opportunities.

In 2022, MHL received a two-year *DuPage County Transformation Partnership* (DCTP) Transformational grant. This grant made possible group mental health programming for low-income residents living in three DuPage County affordable housing communities. As part of the pilot program developed by MHL, partnerships with the Association for Individual Development and NAMI DuPage, another DCTP grant recipient, were established to deliver the specialized services.

"DCTP support has assisted in a strong collaboration amongst multiple mental health-focused organizations, a relationship we hope to replicate in other affordable housing communities," said Mercy Housing Lakefront President Mark Angelini. "The impact on residents' behavioral health has truly been transformative, with more than 75% of participants reporting better mental health, feeling more connected to others, and having positive relationships with loved ones."

The 2024 Immediate Intervention grant awarded to MHL supports this continued partnership by increasing access to on-site, customized mental health programming. ■

More Than \$350,000 Awarded to Support Kindergarten Readiness



ur *Bright & Early DuPage* (B&ED) Initiative recently awarded \$352,000 in grants to support nine DuPage early childhood collaboratives. Area collaboratives are made up of people and organizations who share expertise and resources to promote the development of young children, with the ultimate goal of preparing them to be successful in kindergarten and beyond.

"Kindergarten is a milestone experience for children and their parents, and for some, it may be their first organized learning environment," said Barb Szczepaniak, Foundation vice president for programs. "Collaboratives are providing tools that instill confidence in children and their parents to ensure a positive school experience that ultimately sets them on a lifelong path of success."



Collaborations spent the summer supporting the growth and development of hundreds of children.

The Villa Park Area Early Childhood Collaborative held a back-to-school fair at Tri-Town YMCA. Nearly 500 backpacks were distributed. Parent navigators helped families register for kindergarten, referred children for screenings, and engaged with parents while their children received top-notch face painting.



BELS offered special education support groups, providing parents with educational tools to navigate their children's unique needs.

The Birth to Five Community Coalition hosted parent sessions with discussions on behavior management, early literacy and play, routines, and screen time.

APPLE provided backpacks for more than 200 children in Addison and hosted presentations for parents with a nationally-recognized speaker on social-emotional development during the transition to kindergarten.

A Word From Debbie Venezia

Q. What is unique about Arts DuPage Month?

A. Inspired by the Americans for the Arts National Arts & Humanities Month, we created Arts DuPage Month to celebrate the diverse arts and cultural activities taking place throughout DuPage County. With both social and economic benefits for our communities, we hope the positive experiences had by attendees will encourage lifelong habits of arts engagement.

Q. How do initiatives like Arts DuPage Month impact the community?

A. Stimulating arts engagement also drives the economy. A 2023 study by Americans for the Arts revealed that typical arts and cultural event attendees spend an average of \$38.46 per person, per event, above the cost of admission. Many will go out to dinner beforehand or stop for drinks afterward. Some will buy gas, pay a babysitter, or purchase a program. Event-related spending benefits local merchants and keeps that money in the community, generating valuable tax revenue on a local, regional, and national level.

Q. Who are some of your community partners?

A. BrightSide Theatre, Drury Lane, DuPage Symphony, Elmhurst Art Museum, Local Glass Studio, McAninch Arts Center, Paramount Theatre, Sonny Acres Farm, and Village Theatre Guild, are just a few examples of the many arts groups participating this year.

Q. Which arts experiences are you looking forward to attending this fall?

A. I am trying to squeeze in as many events as I can this October! I have Drury Lane's *The Audience* and Paramount Theatre's *The Full Monty* booked. I am also looking at the Scott Keo #1 Michael Bublè Tribute Worldwide at the McAninch Arts Center and the Fall Festival at Sonny Acres Farm. It will be a fully immersive arts marathon, but I am not one to bypass a good deal! ■

ACH Transfer

Contact us for transfer instructions or visit **dupagefoundation.org/donate**. Initiate ACH transfers by December 26 as they may take more time at year end.

Drop Off at Office

Offices will be closed December 24-25, and open through 3 p.m. on December 31.

IRA Qualified Charitable Distributions (QCDs)

For those 70^{1/4} and older, initiate requests by December 2 to ensure distributions are received by the charity and deposited before year end. For 2024, the QCD maximum is \$105,000/individual or \$210,000/couple. QCDs can be contributed to all Foundation funds, except donor-advised funds. If you have IRA check-writing privileges, the funds must actually leave the custodial account by your IRA administrator's last business day of the year to count against your 2024 RMD.

Contributions of Stock and Mutual Funds

Watch market schedules. Some mutual funds may take up to three weeks for transfer, so work with your account administrator to initiate mutual fund transfers by December 2 and stock transfers by December 26. Contact us at 630.665.5556 to request transfer instructions.

Contributions of Real Estate

The deadline to initiate real estate gifts for 2024 has passed. If you are interested in making such a gift in 2025, please reach out by September 30 of next year. Real estate gifts can minimize capital gains and allow deductions at current market value. Properties under any contract or encumbrance are not usually eligible to be gifted.


